#### **ORDER**

This order may be read with reference to the previous order dated 12.3.2021 vide which the case was adjourned for 26.4.2021 but due to administrative reasons the case was further adjourned for today i.e. 31.5.2021.

2. The appellant has sought the following information:-

> My grandfather Late. Sh. Kundan Lal Sabharwal S/o. Sh. Radha Krishan was a freedom fighter. He belonged to the Ludhiana (Punjab). He was awarded Tamer Patra by the Government of India.

In this regard, refer the certificate which was issued by the Deputy Commissioner, Ludhiana bearing No. 657/CEA dated 17.09.1993 in which it has been mentioned that Mr. Rohit Kumar son of Sh. Vijay Kumar Sabharwal is grandson of freedom fighter Late. Sh. Kundan Lal Sabharwal, who was awarded Tamar Patra by the Government of India (Copy of the Certificate issued by the Deputy Commissioner, Ludhiana & Tamar Patra is enclosed herewith for your kind reference).

Thus, in this regard, in capacity of being a citizen of India within the meaning of Section 3 of The Right to Information Act, 2005, following information is being sought under The Right to Information Act, 2005.

Provide the Certified Copy of those Documents as Information (whether in shape of list or any other format as available on the record of your Public Authority) by the virtue of which Sh. Kundan Lal Sabharwal S/o. Sh. Radha Krishan was declared as a Freedom Fighter.

- 2 Provide the Certified Copy of those Documents as Information by the virtue of which Name of Sh. Kundan Lal Sabharwal S/o. Sh. Radha Krishan was recommended for the Tamar Patra by the Competent Authority.
- 3. As per the records available in your Public Authority, Provide the Information showing the Name & the Designation of that Person/Officer who handed over the Tamar Patra to my late grandfather.
  - 4. Provide Certified Copy of Complete Information (falling within the meaning of Section- 2 (f) read with Section- 2 (j) of the RTI Act, 2005) as available on the records of your Public Authority regarding my late grandfather Sh. Kundan Lal Sabharwal S/o. Sh. Radha Krishan.
- 2. The representative of the appellant Ms Sukhjinder Kaur, Advocate sent the written submissions that she has received a letter duly signed by the Section Officer, Treasurer Charitable Endowments, Mohali bearing No. RTI/2021/11 dated 30.3.2021 & Letter No. RTI/2021/09 dated 30.3.2021 respectively, vide which after a delay of 7 (seven) months, sought information was provided, and the same stands to be satisfactory. She has further requested to penalize the respondent due to delay in supplying the information.
- 3. The representative of the respondents states that the office is functioning with 50% staff as per the instructions issued by the Government of Punjab due to Covid 19 pandemic. He also states that the office was impleaded as necessary part in this case vide orders of the Commission dated 12.3.2021 and a prompt reply/information has been provided to the appellant vide letter bearing No. 11 dated 30.3.2021 and No. 9 dated 30.3.2021. He further requested to close the case.
- 4. Accordingly, the Commission observes that the respondent-Public Information Officer o/o Treasurer Charitable Endowments, Punjab has supplied the information in time. As far as the Public Information Officer o/o the Deputy Commissioner, District Ludhiana is concerned, the said office has also given the reply to the appellant vide letter dated 23.9.2020 that the sought information is not available in their record and the appellant has been advised to contct the office of the Treasurer, Charitable Endowments Punjab. Although as per the provisions of the RTI Act, 2005, the respondent-Public Information Officer should have transferred the RTI application under Section 6(3) of the RTI Act, 2005 to the authority concerned.
- 5. It is a fact on record that the appellant has sought the information related to the year 1993, which is around 28 years old.
- 6. Due to covid 19 pandemic, instructions of the Government of Punjab to work with 50% staff and the submissions of the respondent-Public Information Officer o/o the Deputy Commissioner, District Ludhiana to the appellant to file an application to the authority concerned, the Commission further observes that no further action is required to be taken in this case as the complete information has already been supplied to the appellant to his entire satisfaction. Hence, the case is disposed of and closed.
