

On 08.08.2019, Shri Gurinder Singh was present on behalf of the complainant/applicant and Shri Avtar Singh, Panchayat Officer was present on behalf of Smt. Rajinderjit Kaur, BDPO, Chohla Sahib and a Show Cause Notice was issued to Smt. Rajinderjit Kaur, BDPO, Chohla Sahib.

On 12.09.2019 Shri Gurinder Singh was present on behalf of the complainant/applicant and Smt. Rajinderjit Kaur, BDPO, Chohla Sahib was present along with Ms. Prabhjot Kaur, Panchayat Secretary, Dehra Sahib and the case was adjourned for 30.09.2019.

On 30.09.2019 Shri Gurinder Singh was present on behalf of the complainant/applicant and Smt. Rajinderjit Kaur, BDPO, Chohla Sahib was present along with Ms. Prabhjot Kaur, Panchayat Secretary, Dehra Sahib and the respondents sought a week's time to provide the information to the complainant/applicant.

But today the Commission has received an e-mail sent by the complainant/applicant that he is unable to come present today and informed that no information has been provided to him by the PIO.

Smt. Rajinderjit Kaur, BDPO, Chohla Sahib has come present today and she has filed duly signed reply dated 31.10.2019 to the Show Cause Notice. She has submitted in the reply to the Show Cause Notice that as per the Punjab Govt. notification dated 10.10.2005, she is the PIO at the block level and the panchayat secretaries of the concerned gram panchayats are the public information officers at the gram panchayat level. She further submitted that she is not the PIO of the gram panchayat regarding which the complainant/applicant sought

information. She submitted that Ms. Prabhjot Kaur is the PIO-cum-panchayat secretary of gram panchayat Dehra Sahib, Block Chohla Sahib. She further submitted in the reply that the Show Cause Notice has been wrongly issued to her. She submitted that she has issued notices and instructed the Panchayat secretary-cum-PIO to provide the information to the complainant/applicant, but she has not bothered about the instructions issued by her and has not provided the information to the complainant/applicant. She further submitted that she has wrote another letter no.RTI/119 dated 23.08.2019 to the District Development and Panchayat Officer, Tarn Taran to take action against the concerned panchayat secretary for not doing her duties as per the law and rules because she was not providing the information to the complainant/applicant and not obeying the instruction issued to her. The copies of all the letters are taken in the file of the Commission.

The BDPO, Chohla Sahib further stated that she has also written letter no.140 dated 28.08.2019 to the Director, Rural Development and Panchayat Department, Mohali to take action against the above said panchayat secretary.

So, as per the reply submitted by Smt. Rajinderjit Kaur, BDPO, Chohla Sahib, Distt. Tarn Taran, she is not the PIO at the gram panchayat level rather panchayat secretaries are the PIOs at the gram panchayat level vide Notification dated 10.10.2005 issued by the Punjab Government.

The concerned panchayat secretary i.e. Ms. Prabhjot Kaur, was present before the Commission on the last date of hearings i.e. 12.09.2019 and 30.09.2019, but today she has not come present neither she has provided the information to the complainant/applicant.

The complainant/applicant filed RTI application dated 23.01.2019 and he sought information regarding Gram panchayat Dehra Sahib, Block Chohla Sahib, Distt. Tarn Taran.

So, as per the RTI application dated 23.01.2019 and the Order dated 30.09.2019 the concerned panchayat secretary of above said gram panchayat is liable for the delay in providing the information to the complainant/applicant. The conduct of the concerned panchayat secretary amounts to denial of information and defiance of the provisions of the RTI Act, 2005. She is not bothering about the instructions issued by the Commission as well as about the written instructions issued by the BDPO, Chohla Sahib from time to time for providing the information to the complainant/applicant.

So, under these circumstances a Show Cause Notice is issued to Ms. Prabhjot Kaur, PIO-cum-panchayat secretary of gram panchayat Dehra Sahib, Block Chohla Sahib, who has been transferred about a week ago to Block Naushehra Pannua, Distt. Tarn Taran, that why you have not provided the sought for information to the complainant/applicant within the

stipulated period and why you have not come present before the Commission at the time of

hearing and so why you may not be penalized U/s 19(8) of the RTI Act, 2005 and why the case

may not be referred to the Government for taking disciplinary action against you.

Ms. Prabhjot Kaur, PIO-cum-panchayat secretary of gram panchayat Dehra

Sahib, Block Chohla Sahib, is directed to come personally present before the Commission on

the next date of hearing and file reply to the Show Cause Notice that why you may not be

penalized and why the case may not be recommended for taking disciplinary action against you

to the Government under the service rules applicable. An opportunity of personal hearing will be

afforded to her on the Show Cause Notice. In case the concerned she would not come present

on the next date of hearing then it will be assumed that she do not want to file reply to the Show

Cause Notice and the Show Cause Notice will be decided in her absence.
