ORDER

1. The RTI application is dated 29.10.18 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) and second appeal was filed in the Commission on 30.7.19 under section 19 of the Right to Information Act, 2005 (hereinafter RTI Act.).

7. The respondent must further ensure that every single page of the reply, as well as all appended documents, are duly attested by a competent official.

8. The respondent PIO is also directed to submit a list of all the PIOs/APIOs who have been in charge of handling this RTI request since it was filed on 20.10.18.

8. The PIO must also endeavour to hand over the requested information to the appellant along with a copy to this Commission, well before the next hearing of this appeal case.
