



The Hon'ble Chief Information Commissioner, Punjab welcomed all the members for attending the meeting of the Full Commission.

The following issue was discussed and decided:-

At the outset of the meeting, the Hon'ble CIC briefed the Agenda Item to be considered in the meeting of the Full Commission in regard to the pendency of the cases in the different benches. It was explained that there were 2611 cases pending as on 30.09.2016 and this number had arisen to 2832 as on 31.12.2016 which shows that the pendency of the cases is increasing. It was desired that in order to bring down the pendency, the disposal of cases be increased. During the meeting the Hon'ble CIC also observed that as and when the cases are allotted to any bench of the Commission, it may be ensured that hearing notice is issued to the concerned parties at the earliest so that the appellant/complainant may get information about the Bench to which his case has been allocated and date of hearing of his case has been fixed.

2. Hon'ble Chief Information Commissioner also apprised of the Commission that the two newly appointed State Information Commissioners have completed requisite training in respect of the provisions of RTI Act, 2005 as well as the working of the Benches of the Commission, therefore, cases can be allocated to them which will also be helpful in bringing down the pendency of the cases.
