Item No. 2 - Streamlining of the work relating to Dak received in the Commission

This item relates to streamlining of the work of the Commission specifically with reference to the disposal of the Dak received through e-mail. On the proposal made by the office on the afore-said issue, following decision was taken:-

Item No. 4 - A complaint dated 02.08.2017 by Shri H. S. Hundal, Advocate

The Full Commission observed that the complaint is frivolous. The Members were of the view that a small closet has been erected temporarily with a plywood partition and the same has been done by him on his own accord. No public money has been spent on the same. Item No. 5 - A complaint dated 15.06.2016 by Shri H. S. Hundal, Advocate

A communication from Shri H. S. Hundal, Advocate, has been forwarded by the office of Hon'ble Governor Punjab for appropriate action by the Commission. The Full House considered it in detail. The House is of the view that the complainant is cantankerous busy body, who is in the habit of filing mischievous and insinuatory complaints against all and sundry out of mere frustration or malice. The Commission as well as Public Authorities are being bombarded by him with inane and frivolous appeals. The Commission is regularly getting complaints from various Public Authorities about his unreasonable attitude. The Commission is also getting train of complaints from him on frivolous and inconsequential issues. He seemingly does not have any better thing to do. Having examined his umpteen communications over a period of time, the Commission is of the opinion that he is simply wasting his time, the time of Public Authorities and of the Commission. In these circumstances, Full House decides to advise the office to ignore his communications/complaints on the administrative side, in future.
