In view of the above, **one last opportunity** is given to the appellant to point out deficiencies, if any to the respondent within 15 days from the receipt of this order. On receipt of the deficiencies, the respondent is directed to remove the same before the next date of hearing.

5. Both the parties are directed to appear, in person, on the next date of hearing for deliberations, failing which the case will be decided on merit, ex-parte.

6. To come up on **22.07.2025 at 11.30 AM** for further proceedings in the Commission. Copy of the order be sent to the parties.

### **ORDER**
