3. It is appropriate to mention that Hon'ble Supreme Court of India in its order rendered on 12.12.2011 in Civil Appeal Nos. 10787 10788 of 2011 (arising out of SLP No.32768-32769/2010) has held that while entertaining a complaint under Section 18 of the RTI Act, 2005, the Commissioners have no jurisdiction to pass an order providing for an access to the information.

Since the complainant has approached the Commission under the provisions of Section 18 of the RTI Act, 2005, no directions for providing further information can be given by the Commission. An alternative and efficacious remedy of first appeal is available to the complainant under Section 19(1) of the RTI Act, 2005 which has not been availed in the instant case. Since the complainant is interested in getting the information and the respondent had already supplied the same, therefore, without going into the merits of the case, the matter is remanded back to First Appellate Authority to take appropriate decision in accordance with the provisions of the RTI Act within the prescribed timeline, after giving opportunity of hearing to all concerned by passing a speaking order. A copy of the complaint filed by the complainant is also being sent to him along with this order with the directions that the same may be treated as first appeal. He is also directed that if the First Appellate Authority in this case is from the subordinate/higher office, then this complaint be transmitted to the said First Appellate Authority with the directions to pass appropriate order as mentioned above within the prescribed time line under intimation to the Commission.

4. With these directions the case is **disposed of & closed**. However, the liberty is granted to the complainant to file the 2nd appeal in this case, if he is not satisfied/does not receive the decision of the First Appellate Authority.
