ORDER:

The RTI application is dated **22.05.2024** vide which the appellant has sought the information as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **22.07.2024** and Second Appeal was filed in the Commission on **24.07.2024** under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act). A copy of this order is being sent to the Assistant Commissioner (Excise), Ropar Range, Ropar, to ensure compliance of the above order.

5. Both parties are directed to remain present on the next date of hearing for deliberations. It is also clarified that in case of defiance of this order, the case will be decided on merit, ex-parte.
