ORDER:

The RTI application is dated **18.02.2025** vide which the appellant has sought the information as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **20.03.2025** and Second Appeal was filed in the Commission on **25.06.2025** under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act). Notice of hearing was issued to the parties for today i.e. **02.12.2025**.

2. The appellant is absent, but submitted a letter which was received in the Commission vide diary no. 17654 dated 24.10.2025, mentioning therein that he has received the reply but expressed dissatisfaction and claimed it is still incomplete.

3. The respondent states that a reply has already been sent to the appellant. Further, he states that the information sought by the appellant in his RTI application is regarding recruitment of Assistant Professors in the year 2021, but the requirement of Assistant Professor was quashed by the Government. He also submitted a copy of the same reply to the Commission vide letter dated 14.10.2025, a relevant portion of the same is reproduced below:

4. The Commission has examined the RTI application alongside the reply submitted by the respondent and is of the view that this adequately addresses the RTI application. The Commission is of the view that no further cause of action is required. Hence, this appeal case is **disposed of and closed.**
