The Commission expressed its displeasure on the casual and callous approach adopted by the Respondent in responding to the RTI application. It is felt that conduct of Respondent is

against the spirit of the RTI Act 2005, which has been enacted to ensure greater transparency and effective access to the information.

However, before taking any penal proceedings against the Respondent PIO, the Commission wishes to give **one last opportunity** to him to appear before the Commission on the next date of hearing. The PIO is however, cautioned to exercise due care in future to ensure that correct and complete information is furnished timely to the RTI applicant(s) as provisions of the Act failing which penal proceedings under Section 20 shall be initiated. Further, it is also observed that the respondent has also failed to file his reply to the show cause notice. Hence one last opportunity is also given to the respondent to file his reply on the next date of hearing.

5. Both the parties are directed to appear, in person, on the next date of hearing for deliberations, failing which the case will be decided on merit, ex-parte.
