## APPEAL CASE NO. 6048 OF 2023

### **ORDER:**

1. The RTI application is dated 27.05.2023 vide which the appellant had sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 17.07.2023 and Second Appeal was filed in the Commission on 15.09.2023 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act). Accordingly, the notice of hearing was issued to the parties for today i.e. 03.04.2025.

2. The Respondent stated that requisite information has already been supplied to the appellant vide letter no. 495 dated 02.06.2023, after that no observation has been received from her. Copy of the same is placed on the record.

3. The Appellant is absent, however, the Bench has received the email mentioning therein that the appellant has a personal hearing before the District Court, Gurdaspur. Therefore, the appellant is unable to attend today's Court hearing in the Commission and requested for adjournment. Since the Appellant is absent and nothing has been heard from her regarding the receipt of information, the appellant when contacted on her mobile phone, the incoming calls facility was not available.

4. Thereafter going through information received from the Respondent, the Bench observes that the requisite information provided and is being sent to the appellant along with this order.
