This order may be read with the reference to the previous order dated 12.06.2025.

- 2. The complainant is absent, but an email dated 22.08.2025 has been received from him, mentioning therein that he is unable to attend the hearing due to health issues and he also requests that penalty be imposed on the respondent PIO.
- 3. The respondent PIO, represented by Smt. Seema Sethi, SA, states that a reply was sent to the complainant vide letter no. 9515 dated 04.12.2023, wherein the complainant was duly informed that his RTI application was transferred to the concerned department i.e. Department of Industries and Commerce, under section 6(3) of the RTI Act, 2005, which is within the stipulated period of 30 days. Further, she has filed a detailed reply to the Commission during the course of hearing, which is taken on record.
- 4. After having detailed deliberations with the respondent and going through the case file, it is observed that the respondent has replied within stipulated time period as prescribed under the RTI Act, 2005. There is no evidence of any malice on the part of the PIO.
- 5. This is however, a Complaint Case, wherein the only question before the Commission is to determine whether there was any malafide intent on the part of the respondent PIO to deny / delay the information. In view of the respondent's reply and plea made during this hearing, I am satisfied that there was no malafide intent on the part of the respondent PIO.
- 6. The Complaint is accordingly **disposed of and closed**. Copy of the order be sent to the parties.
