5. After hearing both the parties and going through the case file, it is observed that the

appellant demanded information on two points. Regarding point no. 1, the appellant is

satisfied. Regarding point no.2, the respondent states that the information demanded is

third party information, hence cannot be provided. In so far as information demanded by

the Appellant on point no. 2, the Commission see no reason why it should be denied. As it

does not constitute personal or confidential information of any third party but is, in fact, a

matter of public record. The law is meant to be accessible to all citizens, as it directly

impacts their rights and responsibilities concerning government- operated bus services.

6. In light of the above, the respondent's argument is overruled. The requested

information does not fall within the ambit of Section 8(1)(j) or any other exemption under

the RTI Act. Accordingly, the respondent is directed to provide the information to the

applicant within the stipulated time frame as per the provisions of the Act.
