

ORDER:

1. The matter was earlier heard on 16.07.2025, when only the representatives of the respondent PIO, namely Sh. Varinder Kumar (Accounts Clerk) and Sh. Pardeep Kumar (Clerk), were present. They had submitted a compliance report along with the requisite information, vide letter reference nos. 309 dated 08.07.2025 and 3051 dated 08.07.2025, which were taken on record. On that date, the appellant had sought adjournment through an email, and accordingly, a last opportunity was granted to him to appear and present his case.

2. Today, the appellant is present. An email has been received from the PIO, apprising his inability to attend the hearing and reiterating that the requisite information/reply has already been provided to the appellant. The appellant has submitted that he is not satisfied with the reply furnished by the PIO and insisted that the information sought be supplied.

3. The Commission has carefully considered the submissions made and examined the record. It is noted that the PIO has already provided the available information in compliance with the provisions of the RTI Act, 2005, and wherever the information involved third-party interests, the same has been rightly denied under the Act.

4. The appellant has not demonstrated or established any element of larger public interest that would warrant disclosure of the denied information, as required under Section 8(1)(j) of the RTI Act. Accordingly, the Commission finds that the information, as permissible under law, has already been duly provided by the respondent.

5. In view of the above observations, the appeal stands **DISPOSED OF**. No further action is warranted in the matter.
