2. The appellant is absent but an email has been received from him today mentioning therein that he is unable to attend hearing and sought information has not been supplied by the respondent, which is taken on record. However, the respondent submits that documentation fee amounting to Rs. 27, 826/- was demanded from the appellant to get the sought information. Further, he submits a written reply, which is taken on record and the relevant portion of the same is reproduced below:

3. After having the detailed deliberations with the respondent and examining the case file, it has emerged that the appellant filed the RTI application the PIO, O/o DC, Ludhiana. The said office transferred the RTI application to the DDPO, Ludhiana. Since, the custodian of the record related to the sought information was the BDPO, Sidhwa Bet, Ludhiana, therefore, the said office transferred the RTI application further to the PIO, O/o BDPO, Sidhwa Bet, Ludhiana. It is appropriate to mention that the as per the provisions of the RTI Act, 2005 that the appellant has to file the RTI application to the concerned public authority. It is also a fact that the respondent PIO, O/o BDPO, Sidhwa Bet categorically made the submissions that the appellant sought the voluminous information for which a documentation fee amounting to Rs. 27,826/- was asked from the appellant but due to non receipt of the same, information has not been supplied to the appellant.
4. Keeping in view the specific submissions made by the respondent, mentioned herein, the request of the appellant is not acceptable. However, he is at liberty to deposit Rs. 27,826/- with the respondent public authority in case he intends to get the sought information. Also, the respondent PIO is directed to supply the information on receipt of the requisite fee without any delay.
5. Keeping in view the above, the Commission is of the view that no further action is required to be taken in this case. Hence, the present case is **disposed of & closed**.
