PROCEEDINGS

2. Complainant is absent. The Respondent PIO, Sh. Vijay Vikrant, stated that the sought information had already been provided to the Complainant by the Panchayat Secretary, Makhu, and the receipt of the Complainant had been received. He submitted a letter in this regard to the Commission vide letter reference no. 1464 dated 04.12.2024.

In addition, the Respondent PIO submitted an apology letter for his previous absence in the hearing and requested to waive off the penalty of Rs. 10,000/- imposed on the PIO, BDPO Makhu, vide order dated 26.09.2023.

Decision:

3. The Commission observes that the sought information has been provided to the Complainant, and he has received the same, as evident from the receipt copy of the Complainant. There is no further cause of action left in the case, and the **case is closed.**

4. However, taking into account the request of the PIO himself, the penalty amount of **Rs. 10,000 is waived off.** The PIO is warned to deal with RTI applications promptly in the future.
