5. Today, Sh. Daljeet Singh Gill and Sh. Kapil Dev are appearing on behalf of the respondent and states that the Vee Care Hospital, Abohar is not a 'public authority' within the meaning of Section 2 (h) RTI Act 2005. According to the Respondent, the Hospital is purely a private hospital. He has also filed written reply in this regard. The appellant Sh. Gurinder Singh has not been able to prove that the Vee Care Hospital, Abohar is a public authority within the meaning of Section 2(h) of the RTI Act 2005, the present appeal case is **disposed of and closed**. However the appellant will be at liberty to file fresh RTI application with supported documents to get it declared as a public authority , in case he so wish.
