This order may be read with reference to the previous order dated 09.01.2025,
which is as follows :

"2. The representative of the appellant states that the order dated 25.09.2024, passed by the Commission has still not been complied with by the respondent till date.

3. The respondents O/o GLADA, Ludhiana made a written submission that the appellant has sought action taken on the Letter No.3010-11/CAE/3 dated 19.04.2022, which was sent by the Hon"ble Chief Minister, Punjab to the Deputy Commissioner, Ludhiana. He further submits that after going through the complaint, so sent, by the appellant an appropriate action has been taken and the allotment of residential property of Sh. Daljit Singh Sethi. i.e House No. 930 MIG, Jhamlpur, Ludhiana has already been cancelled. He further submits that after due deliberations with the Counsel of the appellant, it is ascertained that two issues were involved in this case, one i.e. the residential property of Sh. Daljeet Singh, second the temporary shops constructed by Sh. Daljeet Singh Sethi on the adjacent road to Bhandari Kalan Road.

4. Furthermore, he clarified that the residential property is under the jurisdiction of the GLADA, Ludhiana regarding which an appropriate action has already been taken whereas the open space/parks have already been handed over to the

Municipal Corporation, Ludhiana and any action regarding the open space is to be taken by the Municipal Corporation, Ludhiana. With regard to the compensation, the respondent requested for an adjournment to pay the compensation amounting to Rs. 5,000/-.

5. After hearing both the parties, the Commission is of the view that the said matter is under the jurisdiction of the Municipal Corporation, Ludhiana. Accordingly, the PIO O/o Municipal Corporation, Ludhiana, Zone-B is implead as necessary party in this case and is directed to file reply/supply the information on the next date of hearing. A copy of RTI application along with the annexure is being sent to the PIO O/o M.C, Zone-B, Ludhiana, along with this order."

2. The representative of the appellant is present today and submitted that the compensation as has been awarded in this case has not been paid to the appellant till date. The respondent PIO office of G. L. A. D. A., Ludhiana has sent a request that he is not able to attend today's hearing as he has to appear in the Hon'ble Punjab and Haryana High Court. The request is accepted. Accordingly, the respondent PIO is directed to pay the compensation amounting to Rs. 5000/- out of the State Exchequer before the next date of hearing.

3. Further, the PIO office of Municipal Corporation, Ludhiana was impleaded as necessary party in this case but none came appeared from that office. Accordingly, a copy of this order alongwith a copy of the RTI request is **being sent** to the Director, Local Government, Punjab, Chandigarh and Commissioner, Municipal Corporation, Ludhiana to verify the facts and initiate the necessary action against the concerned officials and also ensure the presence of the PIO office of Municipal Corporation, Ludhiana on the next date fixed.

4. With this, the case is **adjourned to 23rd July, 2025 at 11:30 A. M. for hearing at Chandigarh.**

"2. The appellant was not present but he had sent a written submission that he was unable to attend today's hearing at the eleventh hour i.e. in the afternoon, a day prior to the hearing and this type of conduct of the appellant amounts to hassle in delivery of justice and also harassment and humiliation to the respondent, who were present in person. It was also a fact that the other cases of the appellant were also listed today in which namely Sh. Naib Singh Brar, APIO and Sh. Vikas Dhawan (Appeal case No. 1247 of 2022), Sh. Naib Singh Brar, APIO and Sh. Vikas Dhawan (Appeal case No. 1222 of 2022), Sh. Kuldeep Singh, Superintendent and Ms. Sarabjit Kaur, Senior Assistant (Appeal Case No. 2153 of 2021) and Sh. Amarinder Singh, Executive Officer-cum-PIO (Appeal Case No. 1191 of 2021) were present.

The appellant was advised to inform the Commission as well as to the respondent PIO about his non presence well within time in future, if this practice of the appellant would be repeated, a serious view may be taken as per the procedure established by Law.

3. *The appellant was directed to point out, specific deficiency in an annotated form within one month from the issue of this order. Also, the respondent PIO was directed to remove the same, if any deficiency received from the appellant before the next date of hearing.*

4. *The respondent also submitted a copy of an order in Appeal Case No. 4007 of 2023 passed by the Commission on 18.10.2023 and reiterated the same during the course of hearing. The relevant portion of the said order was reproduced below:*

“6. *It is observed that Sh. Lajpat Rai Garg is an RTI Activist and is habitual of filing RTI applications without realizing the practical difficulties which the Public Authorities have to face. Although it is not incumbent upon the Public authorities to provide voluminous information demanded by him yet they have been cooperating with the appellant and providing information at the cost of other important and date-bound cases in their hands. The Hon'ble Supreme Court of India in Civil Appeal No.6454 of 2011 titled as Central Board of Secondary Education Vs Adiitya Bandopadhy and ors. has rightly observed that 75% of the staff of public authorities spends 75% of their time in collecting and furnishing information to applicants under the RTI Act. It has further been observed by the Apex Court that Act should not lead to employees of public authorities prioritizing 'information furnishing' at the cost of their normal and regular duties.*

7. *It has also been viewed that the appellant is never satisfied with the provided information by the public authorities. His behaviour towards the public authorities and the Bench is not conducive to the working of the*

Commission. He does not hesitate to cast aspersions on the bench hearing his appeal case (s). It clearly shows that he is a habitual offender and deserves to be debarred from filing RTI applications in future. In fact, he is using RTI applications as a tool to create terror amongst the public authorities and to exploit them with some ulterior motives. This behavior of the appellant needs to be curbed with a heavy hand."

5. *Also, Sh. Vikas Dhawan filed the written submissions and also tendered unconditional apology, and also requested to withdraw the show cause notice issued to him in this case. The decision regarding the same would be taken on the next date of hearing.*

6. *Both the parties were directed to remain present on the next date of hearing for deliberations, failing which the decision will be taken on the merit, ex-parte. It was also clarified that no further adjournment would be given in this case."*

2. The appellant was directed to file the deficiencies in an annotated form within one month but no such submissions have been received from him. **One last opportunity** is granted to the appellant to file the deficiencies in an annotated form, duly typed, within thirty days from the issue of this order to the respondent under intimation to the Commission. It is also clarified that in case no deficiencies will be filed by the appellant as per the directions, no further adjournment will be given in this case and the case will be decided on merits.

4. The mandate of the RTI act is transparency and accountability. Viewing the attitude in dealing with the RTI application by the respondent casually, **the respondent PIO-cum-Block Development and Panchayat Officer, Nurpur Bedi, Roopnagar-cum-PIO is, thus, issued a show cause notice, by name,** to explain in a self-attested affidavit as to why a penalty @ Rs.250/- per day of delay subject to a maximum of Rs.25000/- till the complete information is furnished, be not imposed under Section 20(1) of RTI Act, 2005 on him for causing willful delay/denial of the information to the RTI applicant and to show cause why a compensation under section 19(8) of the RTI Act,2005, may not be paid to the appellant for causing willful delay/denial of the information for detriment suffered by him.

In addition to the written reply, the Public Information Officer is also given an opportunity under Section 20(1) proviso thereto, for a personal hearing before the imposition of such penalty on the next date of hearing. He may take a note that in case he does not file his written reply and does not avail himself of the opportunity of personal hearing on the next date, it will be presumed that he has nothing to say and the Commission will proceed ex-parte.

5. Also, a copy of this order is **being sent** to the Director Rural Development and Panchayat Officer, Punjab to ensure the presence of the concerned PIO on the next date of hearing. It is also clarified that in case of defiance of this order, the presence of the concerned Public Information Officer will be procured by issuing **BAILABLE WARRANT** and/or disciplinary action may be recommended in this case to the competent authority. A copy of the deficiencies dated 29.08.2023 **is also being** sent to the respondent PIO along with the orders of the Commission.

Also, the respondent PIO is directed to file the specific (point-wise) reply/information, after the receipt of the deficiencies, if so, submitted by the appellant, before the next date of hearing.

3. With this, the case is **adjourned to 22nd May, 2025 at 11:30 A. M. for hearing at Chandigarh.**
