**Order (5th Hearing):**

1. This Order may be read with reference with previous order of the Commission dated **11.03.2025**.

2. The appellant is present in the Commission today. The respondent PIO representative Sh. Rajiv Kumar (Clerk), was contacted telephonically, wherein he apprised the Commission that, in compliance with the Commission's previous order dated 11.03.2025, the requisite information has been sent to the appellant via registered post on 12.03.2025. 5. The respondent PIO/APIO is further directed to remain present before the Commission on the next date of hearing without fail. Failure to comply with these directions shall invite penal consequences under the RTI Act.

### **ORDER :**

1. This order may be read with the reference of previous order of the commission dated 11.03.2025.
2. Both parties are present and heard.

In compliance with the Commission's previous order, the respondent PIO has submitted a reply, received in the Commission vide Diary No. 4771 dated 01.04.2025. However, the appellant has expressed dissatisfaction with the reply, stating that the information provided is incomplete with respect to points 6 to 11 of the RTI application.

In view of the above, the Commission directs the appellant to visit the office of the respondent PIO for inspection of the relevant records. The respondent PIO is directed to issue a written letter to the appellant, inviting him for inspection within 20 days from the date of issuance of this order, clearly specifying the date and time for the same.

The appellant shall comply and visit the office of the PIO on the scheduled date without fail. The PIO is further directed to facilitate the inspection and provide copies of any records identified by the appellant during the inspection, as permissible under the RTI Act.
