ORDER

Nitin Partap Singh i.e. CC:152 of 2023, so he is also recusing himself from the present case as well, as Sh. Nitin Partap Singh is the representative of the appellant. Accordingly, a copy of this order is **being sent** to the Deputy Registrar for reconstitution of the Division Bench for the present case.
