This order may be read with reference to the previous order dated 02.04.2026.

2. The respondent handed over the sought information to the appellant comprising of 23 pages in connection with Appeal Case Numbers 6344, 1158 and 6343 of 2024, duly certified, during the course of hearing. The respondent also submitted a copy of the same, which is taken on record. After going the same, the appellant has not pointed out the deficiency.

3. Keeping in view the above, the Commission is of the view that no further action is required to be taken in this case. Hence, the case is **disposed of and closed.**
