Therefore, one another last opportunity was granted to the appellant to remain present for deliberations, failing which no further adjournment would be given in this case.

- 4. With regard to Point No. 6 Department of Health and Family Welfare, PIO, Ms. Rajinder Kaur, Superintendent-cum-PIO, Establishment Branch-8 (Complaint Cell) was impleaded as necessary party vide order dated 15.05.2024 to file the reply/supply the information with regard to Point No.6, but neither she was present nor had sent any intimation in this regard. It was also a fact that a show-cause notice was issued to her on the hearing dated 14.08.2024. In the interest of natural justice, one last opportunity was granted to her to file a reply with regard to the show-cause notice issued to her and supply the information, failing which the decision would be taken on merits ex-parte.
- 5. Also, a copy of this order was sent to the Principal Secretary, Health and Family Welfare, Punjab Civil Secretariat 2, Sector 9, Chandigarh with the directions to ensure/procure the presence of Ms. Rajinder Kaur, Superintendent-cum-PIO, Establishment Branch-8 (Complaint Cell), failing which her presence would be procured by issuing BAILABLE WARRANTS and/or disciplinary action may also be recommended against her as per provisions of the RTI Act, 2005."
- 2. At today's hearing, the appellant is absent consecutively thrice without intimation. A final opportunity was given to him to remain present and proceed his case inspite of that, he is absent. It seems that he is not interest in pursuing the matter.
- 3. During the hearing dated 14.08.2024, a show cause notice was issued to Smt. Rajinder Kaur, Superintendent-cum-PIO (Establishment Branch-8) O/o Director, Health and Family Welfare, Punjab for non compliance of the Orders of the Bench. At today's hearing, she has made a submission that due to Renal Transplant, she could not attend the hearings of the Bench in time. She also tenders unconditional apology and requested to withdraw the show cause notice issued to her. She further adds that information in regard to point No.6 was related to Civil Surgeon, Moga and they have already supplied the information to the appellant vide letter dated 09.09.2024. She submits that information as available on
