### ORDER

The RTI application is dated 31.01.2023 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 14.03.2023 and the second appeal was filed in the Commission on 10.04.2023 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act). Notice of hearing was issued to the parties for today i.e. 08.01.2025.

2. The representative of the appellant Sh. Manpreet Singh is present without Power of Attorney and made the submission that he is son of Sh. Jagtar Singh, S/o Sh. Balbir Singh information related to whom is sought by the appellant. With regard to the information, he submits that the Police Station Jhabal, District Tarn Taran has supplied the information i.e. a copy of an FIR number 104/1989, FIR number 176/1991, FIR number 17/1992 and requested that the directions may be issued to the respondent PIO to supply the remaining copies of FIR which were lodged from year 1989 to 1992 i.e. during his service which were related to Police encounter. However, the respondent submits that he has brought the remaining information i.e. copies of 06 Number FIR i.e. 147/1991, 125/1990, 136/1990, 139/1990, 147/1990 and 52/1991.

He further clarified that there is no mention of Jagtar Singh in the said FIRs but there is a mention of Police Party in the said FIRs so he has brought a copy of the same, which is handed over to the representative of the appellant during the course of hearing. He further submits that the appellant has not mentioned any Belt Number from which the details of Sh. Jagtar Singh can be derived from the official record, so he has supplied the information on his own.

3. After hearing the contentions made by the respondent, the appellant clarified that he has already conveyed the Belt Number of Sh. Jagtar Singh i.e. 3360 Battalion number 33 Commando 521 and requested that the Police Encounters are around 12 numbers and requested that the respondent may be directed to supply the complete information in which Sh. Jagtar Singh was present in the Police Encounters. It is also a fact that the appellant has not mentioned his Belt No. or the whereabouts of Sh. Jagtar Singh, S/o Sh. Balbir Singh information related to whom has been sought by the appellant and at this stage his RTI application cannot be altered/amended.

4. Keeping in view of the above, the Commission is of the view that no further directions can be given to the respondent PIO as per the provisions of the RTI Act, 2005. Hence, the case is **disposed of closed**.
