Amrit Partap Singh Sekhon, State Information Commissioner, who had demitted the office on 06.04.2024. Thereafter, the case was reallocated to this Bench, which is fixed for today i. e. 09.01.2024.

- 2. The respondent made the submissions that the information is this case has already been supplied to the appellant and nothing more is available on record which could be supplied to the appellant and requested to close the case. However, the appellant is absent continuously second time without any intimation, which appears appellant is not serious and does not intend to pursue the case.
- 3. Keeping in view the above prevailing circumstances, the Commission is of the view that no further action is required to be taken in this case. As such, the present case is **disposed of & closed**.
