APPEAL CASE NO. 6233 OF 2023

Section 4(2) of the RTI Act read as follows:-

“It shall be a constant endeavour of every public authority to take steps in accordance with the requirement of clause (b) of sub section (1) to provide as much information suo motu to the public at regular intervals through various means of communications, including internet, so that the public have minimum resort to the use of this Act to obtain information”.

4. The Hon'ble Central Information Commission has held in the case CIC/AT/A/2007/00112 dated 12.04.2007 that once the information is brought in to the public domain it is excluded from the purview of the RTI Act. The Hon'ble High Court of Delhi in the case of Registrar of Companies and others Vs. Dharmendra Kumar Garg and others decided on 01.06.2012 has held that Right to Information is specifically conferred by the RTI Act is that information which “is held by or under the control of any public authority”.

5. In the light of the above, the Bench cannot accept the contention of the appellant relating to the information available on the website be provided in hard copy.

6. Keeping in view of the above, the Bench concurs with the submission made by the respondent and is of the view that no further action is required to be taken in this case. Hence, the Appeal Case is **disposed of and closed**.
