4. From the perusal of this RTI application it has become clear that the information

demanded by the appellant cannot be supplied inasmuch as it is exempt from disclosure

under Section 8(i) (j) RTI Act 2005. It is observed that the purpose of the Appellant in

seeking this kind of information does not involve any larger public interest for asking the

information as per the details mentioned in his application and it should not be in the

public domain as has been upheld by the Hon'ble Supreme Court and other Hon'ble Courts

to avoid the humiliation and harassment of the employees. Allowing this kind of

information will certainly strengthen the abuse of the process of law.

5. In the above mentioned circumstances, the appellant for seeking the personal

information in the instant case has not been made with due bona fides and in larger public

interest. The furnishing of the information asked for , if provided, would cause

unwarranted invasion of privacy of the individual under Section 8(1)(j) of the RTI Act.

6. In view of the foregoing, no further cause of action is left, hence the above said

appeal case filed by the appellant is **disposed of and closed**. Copy of the order be sent to

ORDER

This order may be read with reference to the previous order dated 27.05.2023 and 19.03.2025 vide which the appellant was not present and the respondent stated that the information has been sent to the appellant.

- 2. Today again the appellant is not present. He has sent his submissions via mail which is taken on record.
- 3. Respondent states that the information has been sent to the appellant. But the appellant has not pointed out any deficiencies so far.
- 4. an email that he is unable to attend today's hearing. However the respondent is present all the way from Ludhiana in all the hearings before the Commission.

From the above-mentioned circumstances, it is ascertained that the Appellant, is unnecessarily dragging the matter with some ulterior motive. The Commission cannot allow such practices. The appellant may take note that there is the judgment of the Supreme Court of India in Civil Appeal No. 6454 of 2011 Central Board of Secondary Education Vs Aditya Bandopadhyay and ors. has in its judgment dated 09.08.2011 observed as under -

(37 Indiscriminate and impractical demands or directions under RTI Act for disclosure of all and sundry information (unrelated to transparency and accountability in the functioning of public authorities and eradication of corruption) would be counter-productive as it will adversely affect the efficiency of the administration and result in the executive getting bogged down with the non-productive work of collecting and furnishing information. The Act should not be allowed to be misused or abused, to become a tool to obstruct the national development and integration, or to destroy the peace, tranquility and harmony among its citizens. Nor should it be converted into a tool of oppression or intimidation of honest officials striving to do their duty. The nation does not want a scenario where 75% of the staff of public authorities spends 75% of their time in collecting and furnishing information to applicants instead of discharging their regular duties. The threat of penalties under the RTI Act and the pressure of the authorities under the RTI Act should not lead to employees of a public authorities prioritising 'information furnishing', at the cost of their normal and regular duties.)

5. The above said appeal case is, therefore **dismissed**. Copies of the order be sent to the parties.
