

- 3. The appellant alleged that the Panchayati land has been exchanged by Sh. Gurdev Singh, Patwariillegally and requested to supply the information.
- 4. The respondent submitted а of order Director, copy of the Consolidation(chakbandi)(ਚੱਕਬੰਦੀ) with regard to the Land exchanged between Sh. Gurdev Singh, Patwari& others (Land 26 canal, 6 Marla) with the Panchayati Land measuring 154 canal, 10 Marla vide intkal no. 1722. The respondent handed over a copy of this order to the appellant during the course of hearing. Regarding the remaining information i.e. a copy of panchayat proceeding, the respondent submits that the same will be supplied to the appellant as the said record is not traceable. He further submits that in case the said proceeding of the panchayat is not available on record then the specific undertaking will be sent to the appellant within one month with a copy to the Commission. Also, he tenders conditional apology and requested to withdraw the show cause notice issued in this case. - 3. Keeping in view the above, the Commission is of the view that no further action is required to be taken in this case. Therefore, this case is disposed of & closed.
