## ORDER:

- 1. This order may be read with the reference of previous order of the commission dated 09.09.2025, both parties were absent. However, a letter from the PIO, O/o BDPO Gidderbaha, District Sri Muktsar Sahib, was received in the Commission vide diary no. 10881 dated 14.07.2025, wherein it was submitted that the RTI application had been transferred under Section 6(3) of the RTI Act to the office of Sh. Rashpal Singh (APO), MGNREGA, Block Gidderbaha, District Sri Muktsar Sahib, Punjab, being the custodian of the relevant information.
