ORDER

This order may be read with reference to the previous order dated 21.01.2025 vide which neither the appellant nor the respondent was present and PIO, o/o DDPO, Gurdaspur was impleaded as respondent no. 2 and he was directed to file reply.

2. The Appellant Sh. Baldev Singh states that he has not received the information till date.

3. Respondent Sh. Harjinder Singh, Panchayat Secy is appearing on behalf of the respondent today in the Commission.

4. After hearing both the parties and examining the case file, it is observed that the information has not been provided to the appellant. As directed in the previous hearing, PIO O/o DDPO, Gurdaspur has failed to file his reply. Sh Harjinder Singh, Pvt Secy is appearing on behalf of the respondent no. 2 today and he is totally oblivious of facts of the case and could not help of the Commission. This shows that the respondent has no regard

for the orders issued by the commission. Therefore, the Commission deem it appropriate to issue show cause notice under section 20 (1) of the RTI Act , 2005, to PIO O/o DDPO, Gurdaspur as to why penalty be not imposed upon him for willful delay / denial in providing the information to the RTI applicant. He is directed to file reply to the show cause notice in writing before the next date of hearing.

In addition to his submission, the PIO is also hereby given an opportunity under Section 20(1) proviso thereto, for a personal hearing before the imposition of such penalty on the next date of hearing. He may note that in case he does not file his submission and does not avail himself of the opportunity of personal hearing on the next date fixed, it will be presumed that he has nothing to say and the Commission shall proceed to take further proceedings against him ex-parte.

5. Both the parties are directed to appear, in person, on the next date of hearing for deliberations, failing which the case will be decided on merit, ex-parte.

6. To come up on **14.05.2025 at 11.30 AM** for further proceedings in the Commission. Copy of the order be sent to the parties.

ORDER

This order may be read with reference to the previous order dated 22.01.2025 vide which the respondent was directed to file point wise reply.

2. Today neither the appellant nor the respondent is present. An email has been received from the appellant at diary no. 527 dated 10.03.2025 mentioning therein that he is unable to attend today's hearing and request to kindly decide the case on merits.

3. Respondent has not informed the Commission about his absence for today's hearing. During the last hearing respondent was directed to file *pointwise* reply. Today, it is observed that neither the respondent has sent any reply nor he has bothered to attend the hearing. This shows that the respondent has no regard for the orders issued by the Commission. This is indeed a serious matter. The Commission observed that there is complete negligence and laxity in the public authority in dealing with the RTI application. The Commission expressed its displeasure on the casual and callous approach adopted by the Respondent in responding to the RTI application. It was felt that conduct of Respondent was against the spirit of the RTI Act 2005, which was enacted to ensure greater transparency and effective access to the information.
