**ORDER**

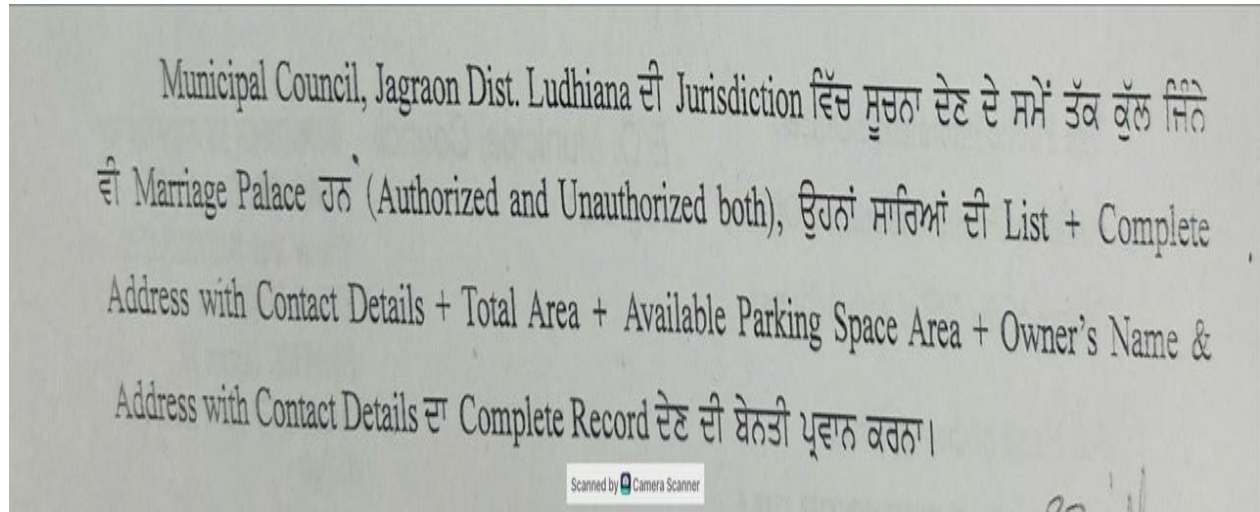
