ਉਪਰੋਕਤ ਵਿਸ਼ੇ ਦੇ ਸਬੰਧ ਵਿੱਚ ਸ਼੍ਰੀ ਜਸਪਾਲ ਸਿੰਘ ਮਾਨ ਪੁੱਤਰ ਸ਼੍ਰੀ ਸੁਖਦੇਵ ਸਿੰਘ, ਵਾਸੀ ਮਕਾਨ ਨੰ. 152 ਪਿੰਡ ਸਹਿਣਾ ਖੇਰਾ, ਤਹਿਸੀਲ ਮਲੇਟ ਜਿਲ੍ਹਾ ਸ੍ਰੀ ਮੁਕਤਸਰ ਸਾਹਿਬ ਵੱਲੋਂ ਆਰ.ਟੀ.ਆਈ ਐਕਟ ਦੇ ਤਹਿਤ ਸਹਿਣਾ ਖੇਡਾ ਅਤੇ ਖੁੱਡੀਆਂ ਗੁਲਾਬ ਸਿੰਘ ਬਹੁਮੰਤਵੀ ਸਭਾਵਾਂ ਦੇ ਸਾਲ 2005 ਤੋਂ ਚਲੰਤ ਸਮੇਂ ਤੱਕ ਦੇ ਆਡਿਟ ਨੇਟਾਂ ਦੀਆਂ ਤਸਦੀਕਸ਼ੁਦਾ ਕਾਪੀਆਂ ਮੰਗੀਆਂ ਗਈਆਂ ਸਨ, ਜੋ ਕਿ ਤੀਜੀ ਧਿਰ ਨਾਲ ਸਬੰਧਤ ਹਨ। ਇਸ ਦਫਤਰ ਵੱਲੋਂ ਤੀਜੀ ਧਿਰ ਨੂੰ ਸੂਚਨਾ ਦੇਣ ਸਬੰਧੀ ਪੁੱਛੇ ਜਾਣ ਮਗਰੇ ਉਹਨਾਂ ਨੇ "ਮਾਨਯੋਗ ਸੁਪਰੀਮ ਕੋਰਟ ਆਫ ਇੰਡੀਆ ਵੱਲੋਂ ਸਿਵਲ ਅਪੀਲ ਨੇ. 9017 ਆਫ 2013 (Arising out of SLP no. 24290 ਆਫ 2012 ਦੇ ਫੈਸਲੇ ਮਿਤੀ 7/10/2013 ਅਨੁਸਾਰ ਇਹ ਸਭਾਵਾਂ ਪਬਲਿਕ ਅਥਾਰਿਟੀ ਨਹੀਂ ਹਨ ਅਤੇ ਸਹਿਕਾਰੀ ਸਭਾਵਾਂ ਸੂਚਨਾ ਦੇ ਅਧਿਕਾਰ ਕਾਨੂੰਨ ਦਾਇਰੇ ਵਿੱਚ ਨਹੀਂ ਆਉਂਦੀਆਂ ਇਹ ਕਹਿੰਦੇ ਹੋਏ ਸੂਚਨਾ ਦੇਣ ਤੋਂ ਸਾਫ ਇਨਕਾਰ ਕਰ ਦਿੱਤਾ ਸੀ, ਅਤੇ ਦੱਸਿਆ ਗਿਆ ਸੀ ਕਿ ਇਸ ਕਾਰਣ ਉਹਨਾਂ ਨੂੰ ਸੂਚਨਾ ਮੁਹੱਈਆ ਨਹੀਂ ਕਰਵਾਈ ਜਾ ਸਕਦੀ। ਇੱਥੇ ਇਹ ਵੀ ਵਰਨਣਯੋਗ ਹੈ ਕਿ ਆਡਿਟ ਪੱਧਰ ਤੇ ਆਡਿਟ ਨੇਟ ਦੀ ਕਾਪੀ ਜਨਤਕ ਨਹੀਂ ਕਰ ਸਕਦਾ ਕਿਓਕਿ ਆਡਿਟ ਨੇਟ ਕਾਪੀ ਵਿੱਚ ਸਭਾ ਦੇ ਸਾਰੇ ਮੈਂਬਰਾਂ ਦੇ ਕਰਜੇ ਅਤੇ ਹੋਰ ਰਕਮਾਂ ਦੀ ਡੀਟੇਲ ਹੁੰਦੀ ਹੈ, ਜੇ ਕਿ ਉਹਨਾਂ ਦੇ ਹਿੱਤਾਂ ਦੇ ਵਿਰੁੱਧ ਹੋਵੇਗੀ। ਆਡਿਟ ਵੱਲੋਂ ਸਭਾ ਦੇ ਆਡਿਟ ਨੈਟ ਦੀ ਇੱਕ ਕਾਪੀ ਸਭਾ ਨੂੰ ਅਤੇ ਇੱਕ ਕਾਪੀ ਸਰਕਾਰ ਪੱਧਰ ਤੇ ਸਬੰਧਤ ਏ ਆਰ ਦਫਤਰ ਸਹਿਕਾਰੀ ਸਭਾਵਾਂ ਨੂੰ ਜਾਰੀ ਕੀਤੀ ਜਾਂਦੀ ਹੈ ਅਤੇ ਇੱਕ ਕਾਪੀ ਬੈਂਕ ਨੂੰ ਦਿੱਤੀ ਜਾਂਦੀ ਹੈ। ਜੇਕਰ ਸ਼ਿਕਾਇਤਕਰਤਾ ਸਭਾ ਦਾ ਮੈਂਬਰ ਹੈ, ਤਾਂ ਉਹ ਆਪਣੇ ਖਾਤੇ ਦੀ ਬਿਨਾ ਕਿਸੇ ਰਕਮ ਭਰੇ ਸਭਾ ਵਿੱਚੋਂ ਜਾਣਕਾਰੀ ਲੈ ਸਕਦਾ ਹੈ। ਜੇਕਰ ਉਸੇ ਸਭਾ ਦੇ final account ਜਿਸ ਵਿੱਚ ਆਰ.ਡੀ ਵਪਾਰਕ ਖਾਤਾ, ਲਾਭ-ਹਾਨੀ ਖਾਤਾ, ਸਭਾ ਦੀ ਖਤਮ ਹੁੰਦੇ ਸਾਲ ਨੂੰ ਬੈਲੰਸ ਸ਼ੀਟ ਸਟਾਕ ਰਿਪੋਰਟਾਂ, ਮੁਲਾਜਮਾਂ ਦੀ ਸੂਚੀ, ਜੇਕਰ ਕਿਸੇ ਮਹਿਕਮੇ ਵੱਲੋਂ ਭੇਤਿਕ ਪਤਤਾਲ ਹੋਈ ਹੈ ਤਾਂ ਉਹਦੀਆਂ ਰਿਪੋਰਟਾਂ ਸਿਰਫ ਦੇ ਰਪਏ ਸਭਾ ਵਿੱਚ ਭਰ ਕੇ ਲੈ ਸਕਦਾ ਹੈ। ਜੇਕਰ ਉਹ ਸਭਾ ਦਾ ਮੈਂਬਰ ਹੀ ਨਹੀਂ ਹੈ ਤਾਂ ਉਸਦਾ ਕੋਈ ਮਤਲਬ ਹੀ ਨਹੀਂ ਹੈ। ਇਸ ਦਫਤਰ ਵੱਲੋਂ ਇਸ ਪੱਤਰ ਦੇ ਸਬੰਧ ਵਿੱਚ ਕੀਤੀ ਗਈ ਸਾਰੀ ਕਾਰਵਾਈ ਦੀ ਕਾਪੀਆਂ ਇਸ ਪੱਤਰ ਨਾਲ ਨੱਥੀ ਕੀਤੀਆਂ ਜਾਂਦੀਆਂ ਹਨ।

ਇਹ ਆਪ ਜੀ ਦੀ ਜਰੂਰੀ ਸੂਚਨਾ ਅਤੇ ਅਗਲੇਰੀ ਲੋੜੀਂਦੀ ਕਾਰਵਾਈ ਹਿੱਤ ਹੈ ਜੀ।

4. In view of the above said it is ascertained that the RTI of the appellant has been adequately addressed. Hence, no further cause of action is left. *However, the copy of the reply, as filed by the respondent, is sent to the appellant along with these orders.* With this, the appeal case filed by the appellant is disposed of and closed. Copy of the orders be sent to the parties.
