#### **FINAL ORDER:**

- 1. This order may be read with the reference of previous order of the commission dated 05.03.2025, vide which both parties were present. The **PIO representatives** handed over a copy of the requested information to the appellant, comprising **675 pages**, and stated that the compensation amount of **Rs. 5,000** would be provided to the appellant within **two days**.
- 2. In today's hearing with the **compliance with the previous order**, the **PIO representative** stated that the complete information has been provided to the appellant, and the compensation amount of **Rs. 5,000** has also been disbursed. Additionally, an **email dated 10.03.2025** has been received from the **BDPO**, **Samana**, detailing the compliance.
- 3. The appellant, present before the Commission, acknowledged receiving the compensation amount but pointed out that the information pages were not in the same sequence as originally available in the official record. However, the respondent PIO representative, Sh. Jasbir Singh (Panchayat Secretary), maintained that the information provided is true and correct as per official records.
- 4. In view of the above, the appellant is advised to visit the PIO's office for a record inspection at a mutually convenient date and time, within 10 days from the issuance of this order, falling which no further opportunities will be provided. The respondent PIO is directed to facilitate this inspection.
