4. Before stating anything further, it would be significant to reproduce the contents of the RTI application itself, which are as follows:-

After going through the above said, the appellant may note that it is settled legal position that information that can be provided under the RTI Act is that which is already on record of the Public Authority. The PIO cannot be asked to create any record for answering the RTI questions. As per the Supreme Court decision in **KhanapuramGandaiahvs Administrative Officer &Ors on 4 January, 2010 in SPECIAL LEAVE PETITION (CIVIL) NO.34868 OF 2009** the definition of information as given under Section 2(f) of the RTI Act 2005, shows that an applicant under Section 6 of the RTI Act can get any information which is already in existence and accessible to the public authority under law. Of course, under the RTI Act an applicant is entitled to get copy of the opinions, advices, circulars, orders, etc., but he cannot ask for any information as to why such opinions, advices, circulars, orders, etc. have been passed. In view of the above, no further cause of action is left. Therefore, the appeal case filed by the appellant is **disposed of and closed**. Copy of the orders be sent to the parties.
