with the department on 30.06.2022 and the reply sent by the respondent on 13.09.2023.

He further states that the appellant has not been provided reply within the time as

prescribed under the RTI Act 2005. For this he demands that the Respondent be penalized

and he be compensated for the detriment suffered.

6. After hearing both the parties and examining the case file, it appears that the PIO

has not provided the information to the appellant within time. Therefore, I deem it

appropriate to issue show cause notice under section 20 (1) of the RTI Act, 2005, to PIO,

o/o BDPO, Sujanpur is directed as to why penalty be not imposed upon him for willful

delay / denial in providing the information to the RTI applicant. He is directed to file reply

to the show cause notice in writing before the next date of hearing.

In addition to his submission, the PIO is also hereby given an opportunity under

Section 20(1) proviso thereto, for a personal hearing before the imposition of such penalty

on the next date of hearing. He may note that in case he does not file his submission and

does not avail himself of the opportunity of personal hearing on the next date fixed, it will

be presumed that he has nothing to say and the Commission shall proceed to take further

proceedings against him ex-parte.

ORDER

The RTI application is dated 06.10.2023 vide which the complainant has sought information as enumerated in his RTI application and complaint case was filed in the Commission on 22.04.2024 under Section 18 of the Right to Information Act, 2005 (hereinafter RTI Act).

- 2. Notice of hearing was issued to the parties for 14.01.2025 in the Commission i.e. today.
- 3. Complainant states that he filed RTI with the department on 06.10.2023 and the respondent has sent reply on 15.02.2024. He further states that he has not been provided the information within the time as prescribed under the RTI Act 2005. He has, therefore, suffered mental harassment. For this the Complainant demands that the Respondent be penalized. He states that he only wants action against the respondent for not sent any reply/information to him within prescribed time.
- 4. The perusal of the file shows that the complainant filed complaint case with the Commission. He has not availed the provision of the Sections 19(1) of the RTI Act by filing an appeal with the First Appellate Authority (FAA). In this regard, the Commission places reliance on a judgment of the Hon'ble Supreme Court dated 12.12.2011 in the matter of Central Information Commissioner vs. State of Manipur wherein it was held as under:

"...28. The question which falls for decision in this case is the jurisdiction, if any, of the Information Commissioner under Section 18 in directing disclosure of information. In the impugned judgment of the Division Bench, the High Court held that the Chief Information Commissioner acted beyond his jurisdiction by passing the impugned decision dated 30th May, 2007 and 14th August, 2007. The Division Bench also held that under Section 18 of the Act the State Information Commissioner is not empowered to pass a direction to the State Information Officer for furnishing the information sought for by the complainant."

As such, since the complainant has approached the Commission under the provision of Section 18 of the RTI Act, 2005, no directions for providing further information can be given by the Commission.

5. In this case, the complainant wants action against the respondent for not sent any reply/information to him within prescribed time. This shows that the respondent has no regard for the RTI regime. Therefore, I deem it appropriate to issue show cause notice under section 20 (1) of the RTI Act , 2005, to PIO O/o Secretary Education, Punjab as to why penalty be not imposed upon him for willful delay / denial in providing the information to the RTI applicant. He is directed to file reply to the show cause notice in writing before the next date of hearing.

In addition to his submission, the PIO is also hereby given an opportunity under Section 20(1) proviso thereto, for a personal hearing before the imposition of such penalty on the next date of hearing. He may note that in case he does not file his submission and does not avail himself of the opportunity of personal hearing on the next date fixed, it will be presumed that he has nothing to say and the Commission shall proceed to take further proceedings against him ex-parte.
