ਆਪ ਜੀ ਦੇ ਧਿਆਨ ਵਿੱਚ ਲਿਆਉਣ ਯੋਗ ਹੈ ਕਿ ਸੰਬੰਧਤ ਬਿਨੈਕਾਰ ਵੱਲੋਂ ਜ਼ੋ ਆਰ.ਟੀ.ਆਈ ਐਕਟ ਤਹਿਤ ਸੂਚਨਾਵਾਂ ਦੀ ਮੰਗ ਕੀਤੀ ਜਾਂਦੀ ਹੈ,ਉਸ ਵਿੱਚ ਇਸਦੇ ਆਪਣੇ ਕੋਈ ਵਹੀਕਲ ਦੀ ਸੂਚਨਾ ਨਹੀਂ ਹੁੰਦੀ ਅਤੇ ਨਾ ਹੀ ਕੋਈ ਜਨਹਿੱਤ ਨਾਲ ਸੰਬੰਧਤ ਸੂਚਨਾ ਹੁੰਦੀ ਹੈ।ਇਸ ਵੱਲੋਂ ਪੂਰੇ ਪੰਜਾਬ ਵਿੱਚ ਪਿਛਲੇ ਕਈ ਸਾਲਾਂ ਦੀ ਸੂਚਨਾ ਦੀ ਮੰਗ ਕੀਤੀ ਜਾਂਦੀ ਹੈ ਜ਼ੋ ਕਿ ਕਰਮਚਾਰੀਆਂ ਨੂੰ ਬਲੈਕਮੈਲ ਅਤੇ ਪ੍ਰੇਸ਼ਾਨ ਕਰ ਰਿਹਾ ਹੈ।ਇਸ ਦਾ ਮਕਸਦ ਦਫਤਰਾ ਨੂੰ ਪ੍ਰੇਸ਼ਾਨ ਕਰਕੇ ਆਪਣਾ ਨਿਜੀ ਫਾਇਦਾ ਲੈਣਾ ਹੈ।ਇਸ ਵੱਲੋਂ ਮੰਗੀ ਗਈ ਸੂਚਨਾ ਨੂੰ ਕੀਏਟ ਵੀ ਕਰਨਾ ਪੈਦਾ ਹੈ,ਕਿਉਕਿ ਇਨਾ ਵੱਲੋਂ ਜ਼ੋਂ ਸੂਚਨਾ ਦੀ ਮੰਗ ਕੀਤੀ ਜਾਂਦੀ ਹੈ,ਉਹ ਉਸ ਹਿਸਾਬ ਨਾਲ ਨਹੀਂ ਹੁੰਦੀ ਹੈ।

ਇਹਨਾ ਵਲੋਂ ਜ਼ੋ ਆਰ.ਟੀ.ਆਈ ਪਾਈ ਜਾਂਦੀ ਹੈ,ਉਹਨਾ ਦੇ ਕੇਸਾ ਦੀ ਅਪੀਲ ਕੇਸ ਮਾਨਯੋਗ ਅਦਾਲਤ ਵਿੱਚ ਚਲ ਰਹੀ ਹੁੰਦੀ ਹੈ।ਉਹਨਾ ਕੇਸਾ ਦੇ ਪੈਰਵੀ ਕਰਨ ਵਿੱਚ ਇਸ ਦਫਤਰ ਦੇ ਮੁਲਾਜਮ ਦੇ ਕਈ ਚੱਕਰ ਚੰਡੀਗਤ ਲੱਗਦੇ ਹਨ,ਇਸ ਕਾਰਨ ਦਫਤਰ ਦਾ ਕੰਮ-ਕਾਜ ਵੀ ਪ੍ਰਭਾਵਿਤ ਹੁੰਦਾ ਹੈ ਅਤੇ ਮਾਨਯੋਗ ਅਦਾਲਤ ਵੱਲੋਂ ਲਗਾਏ ਗਏ ਜ਼ੁਰਮਾਨੇ ਨੂੰ ਵੀ ਪੀ.ਆਈ.ਉ ਵੱਲੋਂ ਆਪਣੀ ਜੇਬ ਵਿੱਚੋਂ ਭਰਨਾ ਪੈਦਾ ਹੈ।ਇਹਨਾ ਦੀ ਪੂਰੇ ਪੰਜਾਬ ਵਿੱਚ ਪਾਈਆ ਹੋਈਆਂ ਆਰ.ਟੀ.ਆਈ ਦੀ ਜਾਂਚ ਕੀਤੀ ਜਾਵੇ ਤਾਂ ਇਸਤੋਂ ਪਤਾ ਲੱਗ ਜਾਵੇਗਾ ਕਿ ਇਹ ਕਿੰਨੀਆ ਕੁ ਲੋਕ ਹਿੱਤ ਵਿੱਚ ਹਨ ਜਾਂ ਇਹਨਾ ਦੇ ਨਿਜੀ ਹਿੱਤ ਵਿੱਚ ਹਨ।

ਉਪਰੋਕਤ ਅਨੁਸਾਰ ਇਸ ਦਫਤਰ ਵੱਲੋਂ ਇੱਕ ਬੇਨਤੀ ਪੱਤਰ ਮਾਨਯੋਗ ਪ੍ਰਮੁੱਖ ਸਕੱਤਰ ਟਰਾਸਪੋਰਟ ਵਿਭਾਗ ਪੰਜਾਬ ਚੰਡੀਗੜ ਜੀ ਨੂੰ ਪੱਤਰ ਨੰ.ਆਰ.ਟੀ.ੳ/ਆਰ.ਟੀ.ਆਈ– 2428–ਏ ਮਿੱਤੀ 24–12–2024 ਅਤੇ ਇਸਦਾ ਉਤਾਰਾ ਮਾਨਯੋਗ ਸਟੇਟ ਟਰਾਂਸਪੋਰਟ ਕਮਿਸ਼ਨਰ ਪੰਜਾਬ ਚੰਡੀਗੜ ਜੀ ਨੂੰ ਪਿੱਠ ਅੰਕਣ ਨੰ. ਆਰ.ਟੀ.ੳ/ਆਰ.ਟੀ.ਆਈ– 2429–ਏ ਮਿੱਤੀ 24–12–2024 ਰਾਹੀ ਵੀ ਭੇਜਿਆ ਗਿਆ ਸੀ ਜਿਸਦੀ ਕਾਪੀ ਇਸ ਪੱਤਰ ਨਾਲ ਨੱਥੀ ਹੈ ਜੀ।

ਇਸ ਕਰਕੇ ਇਸ ਦਫਤਰ ਨੂੰ ਆ ਰਹੀਆ ਮੁਸ਼ਕਿਲਾ ਦਾ ਕੋਈ ਪੁਖਤਾ ਹੱਲ ਕਰਨ ਦੀ ਕ੍ਰਿਪਾਲਤਾ ਕੀਤੀ ਜਾਵੇ ਤਾਂ ਜੋ ਦਫਤਰ ਦੀ ਪਬਲਿਕ ਡੀਲਿੰਗ ਦਾ ਕੰਮਕਾਜ ਪ੍ਰਭਾਵਿਤ ਨਾ ਹੋਵੇ।ਆਪ ਜੀ ਨੂੰ ਬੇਨਤੀ ਹੈ ਕਿ ਇਸ ਆਰ.ਟੀ.ਆਈ ਐਕਟੀਵਿਸਟ ਖਿਲਾਫ ਬਣਦੀ ਕਾਰਵਾਈ ਕਰਨ ਦੀ ਕ੍ਰਿਪਾਲਤਾ ਕੀਤੀ ਜਾਵੇ ਜੀ।

4. Keeping in view the above, the Commission finds that the RTI application has been adequately addressed and the case is **closed**.
