### **ORDER:**

The above said appeal case was earlier allocated to Shri Anumit Singh Sodhi, State Information Commissioner. After his retirement, the said appeal case was allocated to the undersigned Bench. The RTI application is dated **11.10.2022** vide which the appellant has sought the information as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **09.12.2022** and Second Appeal was filed in the Commission on **08.02.2023** under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act). Notice of Hearing was issued to the parties for today i.e. **15.04.2025**.

2. The respondent is absent without intimation, which shows his carelessness and casual attitude towards the notices of the Commission. The perusal of the case files shows that the respondent has submitted an email dated 19.03.2025, mentioning therein that the sought information has already been supplied to the appellant along with the appellant's receiving, mentioning therein that he is satisfied with the supplied information.

3. However, the appellant is absent without intimation. It is also a fact that notice of hearing was sent to him through registered post, but even though he is absent, which seems his absence is intentional and willful. The prima facie appears that the appellant does not intend to pursue the case and he has nothing to say in this regard.

4. Keeping in view of the above and examining the case file, the Commission is of the view that no further cause of action is required. Hence, the appeal is **disposed of and closed.** Copy of the order be sent to the parties.
