"information" means any material in any form, including records, documents, memos, email, opinions, advices, press releases, circulars, orders, logbooks, contracts, report, papers, samples, models, data material held in any electronic form and information relating to any private body which can be accessed by a public authority under any other law for the time being in force."

- 5. At the outset the Commission observed that under the provision of the RTI Act 2005, only such information as is available and existing and held by the public authority or is under control of the public authority can be provided. The PIO is not supposed to create information that is not a part of the record. He is also not required to interpret information or furnish replies to hypothetical questions. The PIO is not supposed to have any material which is not before him; or any information he could have obtained under law. Under Section 6 of the RTI Act, an applicant is entitled to get only such information which can be accessed by the "public authority".
- 6. Keeping in view the facts of the case and the submissions made by the respondent, no further intervention of the Commission is required in the matter. The Appeal stands **disposed** accordingly. Copy of the order be sent to the parties.
