### **ORDER:**

This order may be read with the reference to the previous order dated **05.04.2023**.

Earlier the case was heard by Sh. Anumit Singh Sodhi, State Information Commissioner, Punjab, who has demitted the office on **20.10.2023**. Notice of Hearing was issued to the parties for **03.12.2024**, which was postponed and fixed for today i.e. **18.12.2024**.

2. The respondent states that demanded information was third party and submitted his written submission during the hearing vide letter no. 3577 dated 16.12.2024, along with reply of show cause notice issued to him vide this Commission's order dated 05.04.2023.

3. After having the detailed deliberations with the respondent, I am of the view that the show cause notice which was issued to the PIO concerned vide order dated 05.04.2023, is **dropped**.

4. The appellant is absent without intimation. It is also a fact that notice of hearing was sent to him through registered post even then he is absent, which seems his absence is intentional and willful. The prima facie appears that the appellant does not intends to pursue the case.
