Final Order

2. The appellant is absent today. However, an email dated 16.12.2024 has been received by the undersigned bench, wherein the appellant has provided reasons for not attending the hearing.

3. The respondent, **Smt. Ravinder Kaur Chhatwal, Dy. D.E.O (EE)-Cum-PIO**, stated before the Commission that the information sought by the appellant has already been supplied via letter reference no. **37332 dated 08.02.2023**, and no information related to this RTI application is pending.

4. She further mentioned that despite receiving the information, the appellant filed a second appeal with the Commission on **06.04.2023**, resulting in her office having to send a representative to attend each hearing. Today, she personally appeared before the Commission to submit the same information again, which hampers her office work. She requested the Commission to close the case and prevent the appellant from repeatedly seeking the same information, as it causes unnecessary harassment to public offices. Today, the said information is also submitted to the Commission via letter reference no. **317480 dated 10.12.2024**, which is taken on record.

5. Considering the facts of the case and after reviewing the information provided by the respondent, the Commission finds that the information has been supplied to the best extent possible. The appellant is **cautioned** against making repeated demands for the same information at different levels of appeal and second appeals.

Accordingly, this case is **closed**.
