ORDER:

This order may be read with reference to the Commission's previous orders dated **21.05.2025, 16.09.2025, and 13.11.2025**.

2. In the order dated **21.05.2025**, the penalty of ₹25,000/- imposed upon the PIO was confirmed, and the DDO, RTO Amritsar, was directed to deduct and remit the amount to the State Treasury. The PIO was also directed to provide complete information to the appellant and appear in person. Through the subsequent order dated **16.09.2025**, the Commission reiterated that the directions issued on 21.05.2025 remain in force and must be complied with in letter and spirit.
3. Today, both parties are present. The PIO representative, Shri Ravinder Singh (Jr. Asstt.), appeared but stated that he is not aware of the case and could not provide any update regarding compliance.
4. In view of the above, the Commission directs that:
 - i) Shri **Leela Singh (MVI-cum-PIO, RTO Amritsar)** and Shri **Khushdil Singh (RTO, Amritsar)** shall appear in person before the Commission on the next date of hearing along with complete compliance regarding supply of information and remittance of the confirmed penalty;
 - ii) Failure to comply will invite initiation of **coercive proceedings, including issuance of a Bailable warrant**, as permissible under the RTI Act, 2005.

5. Next hearing on 28.01.2026 at 11.00 AM at Punjab State Information Commission, Red Cross Building, Madhya Marg, Sector 16, Chandigarh.
