(We hold that under Section 6(3) of the Act *ibid* the legal obligation of a PIO who receives a request for information under Section 6(1) of the Act is limited to transfer this request to only one public authority that holds the information. This obligation does not extend to transfer the request to multiple public authorities.)

In view of the above, I, therefore, order that the respondent PIO O/o Regional Transport Authority, Ludhiana be impleaded as necessary party in this case and is directed to file a point-wise written reply along with the documentary evidence in an annotated form and a copy of the same be sent to the appellant within 15 days from the receipt of this order.
