ORDER:

The above said appeal case was earlier allocated to Shri Anumit Singh Sodhi, State Information Commissioner. After his retirement, the said appeal case was allocated to the undersigned Bench. The RTI application is dated **27.09.2022** vide which the appellant has sought the information as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **22.11.2022** and Second Appeal was filed in the Commission on **23.01.2023** under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act). Notice of Hearing was issued to the parties for today i.e. **19.03.2025**.

2. The respondent is absent without intimation, which shows his carelessness and casual attitude towards the notices of the Commission. It is also a fact that notice of hearing was sent to the PIO through registered post in spite of that, he is absent. The perusal of the case file shows that the respondent has sent an email dated 25.7.2023, mentioning that the sought information had been supplied to the appellant on 19.11.2022 by registered post.

3. However, the appellant is also absent without intimation. It is also a fact that notice of hearing was sent to him through registered post even then he is absent, which seems his absence is intentional and willful. The appellant, Shri Ram Kumar, was contacted on telephone where he confirmed that he had received the sought information from the respondent and was satisfied with it.
