## Complaint Case No. 123 of 2025

**Present :** Advocate, Sh. Ishan Kaushal, the complainant.

### ORDER

The RTI application is dated 21.03.2025 vide which the complainant sought information as enumerated in his RTI application and Complaint was filed in the Commission on 27.05.2025 under section 18 of the Right to Information Act, 2005. Notice of hearing was issued to the parties for today i.e. 19.06.2025.

2. The complainant submits that a stringent action be taken against the respondent as they have not complied with the provisions of the RTI Act, 2005, in letter and spirit. None is present on behalf of the respondent but Sh. Rajesh Kumar, OSD to Commissioner, MC, Jalandhar, is present in Appeal Case No. 7087 of 2024-Ms. Vandana Vs. Commissioner, MC, Jalandhar, which is listed for hearing today, who was asked the names of Additional Commissioner and Assistant Commissioner in this case and he submits that Sh. Suresh Kumar Sharma is the Additional Commissioner and Sh. Rajesh Khokhar, is the Assistant Commissioner.

3. Viewing the attitude in dealing with the RTI application by the respondent in a casual manner, **Sh. Suresh Kumar Sharma, Additional Commissioner and Sh. Rajesh Khokhar, Assistant Commissioner, is, thus, issued a show cause notice**, to explain in a self-attested affidavit as to why a penalty @ Rs.250/- per day of delay subject to a maximum of Rs.25000/- till the complete information is furnished, be not imposed under Section 20(1) of RTI Act, 2005 on them for causing willful delay/denial of the information to the RTI applicant.

In addition to the written reply, the Public Information Officer is also given an opportunity under Section 20(1) proviso thereto, for a personal hearing before the imposition of such penalty on the next date of hearing. They may take a note that in case they does not file their written reply and does not avail themselves of the opportunity of personal hearing on the next date, it will be presumed that they have nothing to say and the Commission will proceed ex-parte.
