The appellant has not submitted any written submission and nor has he opted to be present at today's hearing. The prima facie appears that the appellant does not intend to pursue the case and he has nothing to say in this regard.

4. The appeal is accordingly **disposed of and closed**. Copy of the order be sent to the parties.
