**ORDER**

This order may be read with reference to the previous order dated 10.10.2024.

2. The appellant, Mrs Suresh Devi is represented through her son, Mr. Vinod Kumar. The appellant has another son namely Sh. Jagmohan Singh. It is also a fact that the appellant filed the Civil Writ Petition number 25667 of 2023, which has been disposed of by the Hon'ble Punjab and Haryana High Court on 5 February 2024, through Sh. Vikas Bahl, Justice, Hon'ble Punjab and Haryana High Court, wherein, it has been directed to the Chief Information Commissioner, Punjab to decide the appeal filed by Mrs Suresh Devi, appellant as expeditiously as possible in accordance with the law.

3. The appellant has sought the following information ;

- “ 1) *Copy of rent deed/rent agreement in favour of the name of Ms. Radhika Puri, CJM, Ludhiana at House no. 66-A, Aggar Nagar, Ludhiana, bearing Khasra No. 35//16, Khata No. 144/221, Sunet Hadbast No. 159 Year 2006-07 measuring 481 Sq Yards.*
- 2) *Supporting documents, at the time of execution of Rent Deed.*
- 3) *Who signed the rent agreement/rent deed on owner's side.*
- 4) *Name of the concerned person, who present at the time of execution of rent deed.*
- 5) *All documents integral part of the Rent Agreement/Rend Deed.”*

4. Sh. Vinod Kumar also submitted a copy of General Power of Attorney and a copy of the Sale Register along with Jama Bandi, Water Supply and Sewage Charges, Municipal Corporation Charges etc. in support of his claim and requested that the directions may be issued to the respondent to supply the complete information. However, the respondent clarified that Ms. Radhika Puri, Judge has made an agreement with Sh. Jagmohan Singh, who is having 'hiwanama' in his favour, but due to dispute between the family of the appellant house was vacated just after three months and no rent has been paid till date. Further, he clarified that the house was immediately vacated as when it came to the knowledge that the title of the property is disputed primarily between the family members, which shows the bonafide of the tenant. Also, he made the statement that due to dispute in the title, the rent, which has not been paid so far as the authorities cannot make out to whom the rent is to be paid. He further made the submissions that the information sought by the appellant can not be supplied to the appellant being 'third party'. Undoubtedly, the appellant submitted the number of documents in his favour but from the perusal of the said documents, it can not be said who has the genuine documents which is under the jurisdiction of a Civil Court. Therefore, no further directions can be given to the respondent as per the provisions of the RTI Act, 2005.

5. Keeping in view the above, the Commission is of the view that no further action is required to be taken in this case. Hence, the case is **disposed of and closed**.
