the information. Since the complainant has approached the Commission under the provisions of Section 18 of the RTI Act, 2005, no directions for providing further information can be given by the Commission.

- 5. Since, an alternative and efficacious remedy of first appeal is available to the complainant who is interested in getting the information, accordingly, without going into the merits of the case, the case is remanded back to the First Appellate Authority i.e. O/o Deputy **Director**, **Higher Education**, **Mohali**, to take appropriate decision in accordance with the provisions of the RTI Act, 2005, within the prescribed timeline, after giving opportunity of hearing to all concerned by passing a speaking order.
