ORDER:

1. This order may be read in reference to the previous order of the Commission dated **11.11.2025**, whereby the Respondent PIO was directed to comply with the directions of earlier orders and to submit a show cause reply for non-compliance and absence from the hearing.
2. Today, the Respondent PIO is represented by **Sh. Gurpreet Singh (J.E.)**, O/o Punjab Water Supply and Sewerage Division, who submits a **show cause reply vide letter ref. no. SPL-1 dated 20.01.2026** along with a reply to the RTI application **vide letter ref. no. 562 dated 30.06.2025**, copy of which has also been endorsed to the appellant. As per the said reply, it has been clarified that **no work was carried out by the department from the permanent gate to the temple of Mai Rani in S.A.S. Nagar and village Sanghera during the financial years March 2020 to April 2023**, as per the office records.
3. In view of the above submission and compliance placed on record, the Commission finds that the Respondent has now complied with the directions of the Commission and furnished the information as available on record. Accordingly, **no further action is warranted in the matter** and the **show cause notice is hereby dropped**.
4. **The case is disposed of accordingly.**

ORDER

1. This order may be read with reference to the Commission's previous order dated **12.11.2025**, whereby the Respondent was directed to supply complete information pertaining to **Point No. 2** of the appellant's RTI application.
2. Today, **both parties are present**. The Respondent, **Sh. Jagjit Singh (Panchayat Secretary)**, submits that the requisite information has been supplied to the appellant in compliance with the Commission's last order. The appellant acknowledges receipt of the information; however, he has expressed grievance regarding the **undue delay and harassment** faced by him in obtaining the information.
3. The Commission notes that although compliance has eventually been made, the **avoidable delay and repeated directions** point towards **casual and negligent handling of the RTI application**, which defeats the very spirit of the RTI Act, 2005. The Respondent PIO is, therefore, **severely warned** to strictly adhere to the statutory timelines, to deal with RTI applications with due diligence and seriousness, and to ensure that such lapses are **not repeated in future**. The Respondent is further cautioned that **any recurrence of such conduct shall be viewed seriously** and may invite action under the provisions of the RTI Act, 2005.
4. In view of the compliance now placed on record, **no further action is warranted** and the case is **DISPOSED OF** accordingly.

ORDER:

1. This order may be read with reference to the Commission's previous order dated **13.11.2025**.
2. The appellant has sought information pertaining to the **names of employees (by name karamchari) working under the Civil Surgeon, Fazilka (Punjab)** and copies of the **certificates submitted by them at the time of joining service**.
3. Today, both the parties are present. The Respondent, **Dr. Ashima Sethi (ENT Specialist)**, has made submissions **telephonically** during the hearing. Further, an email has been received from the Respondent PIO, which is taken on record. The Respondent PIO has submitted that the appellant has sought **personal information of third-party employees**, which was furnished by the concerned employees to the department with a clear request that the same **should not be disclosed to any third party**. The appellant was accordingly informed of non-disclosure **vide letter no. 2134 dated 06.09.2023**. The Respondent has also relied upon instructions issued by the **Department of Governance Reforms & Public Grievances, Government of Punjab**, **vide letter dated 09.08.2021**, discouraging disclosure of such personal information.
4. The Commission observes that the information sought pertains to **personal service records of third-party employees**, disclosure of which is exempt under **Section 8(1)(j) of the RTI Act, 2005**, and the appellant has **failed to establish any larger public interest** warranting disclosure of the same.
5. In view of the above, the Commission finds the reply furnished by the Respondent PIO to be **justified and in accordance with the provisions of the RTI Act, 2005**. Accordingly, **no further intervention is required** and the **appeal is DISMISSED**.

ORDER:

1. This order may be read with reference to the Commission's earlier order dated 13.10.2025, wherein a Show Cause Notice was issued to Sh. Sukhwinder Singh (XEN Civil) for non-compliance of the directions of the Commission.
2. Today, both the parties are present. In compliance with the aforesaid order, Sh. Sukhwinder Singh (XEN Civil) appears before the Commission and submits that the requisite reply/information has been supplied to the appellant vide letter ref. no. 005553 dated 04.12.2025. He further submits that all points of the RTI application have been duly addressed and that no information remains pending.
3. The appellant, present today, submits that he is not satisfied with the reply furnished and states that certain discrepancies in the information supplied were brought to the notice of the Commission vide his written submissions dated 15.12.2025 and 22.12.2025.
4. After keeping in view the facts and circumstances of the case and the submissions made by both the parties, the Commission finds that the respondent has supplied the information as available on the official record and, *prima facie*, the reply furnished by the Respondent PIO appears to be satisfactory. However, the Commission also notes the appellant's contention regarding alleged discrepancies.
5. At this stage, it is pertinent to observe that under the provisions of the RTI Act, 2005, the jurisdiction of the Commission is confined to examining whether information, as held and available on record with the public authority, has been provided or not. The Commission is neither empowered to verify the correctness of the records maintained by the public authority nor to adjudicate upon disputes relating to the authenticity or accuracy of such records or to take any consequential action thereon.

6. In order to place the matter beyond doubt and to ensure due compliance, the Commission deems it appropriate to direct the Respondent PIO to file a formal undertaking.
7. **Accordingly, the PIO/Respondent is directed to file a duly signed written undertaking certifying that the information supplied to the appellant has been furnished strictly as per the records available with the public authority, that all points of the RTI application stand fully complied with, and that no information has been withheld, concealed or remains pending for disclosure.**
8. The original copy of the said undertaking shall be sent to the appellant, with a copy endorsed to the Commission, within **five days** from the date of receipt of this order.
9. With the above observations and directions, the appeal is **disposed of**.

1. 5. It is a **settled position of law** that under the **RTI Act, 2005**, the Public Information Officer is obligated to provide **only such information as is held or available on record with the concerned public authority**. The Act **does not cast any obligation upon the PIO to create information, to procure information from another public authority, or to provide records which are not in its custody or control** at the relevant time.
6. In view of the **above facts and circumstances**, the Commission finds that the **respondent has discharged his obligation under the RTI Act** by duly apprising the appellant of the **factual position**. **No further intervention of the Commission is warranted** in the matter.
7. Accordingly, the appeal is **disposed of**.
