ORDER

This order may be read with reference to the previous order dated 01.10.2025 vide which one last opportunity was given to the Respondent-PIO to provide complete information to the appellant and also to appear personally on the next date of hearing i.e today and file his reply to the show-cause notice.

2. Today the appellant states that the complete information has not been provided to him till date. He requests that action be taken against the Respondent-PIO for delay in providing the information and harassment caused to him.

3. Sh Naresh Kumar, Jr Asstt. is appearing on behalf of the respondent today. He states that the information has been provided to the appellant.

4. After hearing the appellant and going through the case file, it is observed that the appellant filed RTI on 03.08.2024 but after lapse of more than twelve months, no information has been given to him, which shows that the respondent has no regard for the orders issued by the Commission. Neither the respondent-PIO has bothered to provide the information to the appellant nor he has filed his reply to the show-cause notice. This is indeed a serious matter.

5. The Commission observed that there is complete negligence and laxity in the public authority in dealing with the RTI application. It is abundantly clear that such matters are being ignored which reflects disrespect towards that RTI act 2005 itself. The Commission expressed its displeasure on the casual and callous approach adopted by the Respondent in responding to the RTI application. It is felt that conduct of Respondent is against the spirit of the RTI Act 2005, which has been enacted to ensure greater transparency and effective access to the information. Such kind of behavior of a Government servant needs to be condemned and such employees need to be taught a good lesson so that rest of the employees have a right kind of message to wake up and perform their duties under the RTI Act for ensuring complete transparency and due accountability in the governance affairs of the public authorities.

6. However, in the interest of justice, an opportunity is given to **PIO- Sh Mohan Singh, ATP** to appear personally on the next date of hearing and file his reply to the show cause notice. Further, the respondent-PIO is also directed to file his point-wise specific reply, pertaining to the RTI of the appellant, on affidavit, duly notarized. *It is also made clear that in case of failure to comply with the orders of the Commission, penal action shall be taken against the Respondent-PIO.*
