**ORDER:**

This Order may be read with reference to the previous order dated 28.10.2025 passed by the Commission and case was adjourned to 01.12.2025 but due to some administrative reason, the same was postponed and fixed for today's hearing. i.e. 21.01.2026.

2. The appellant is absent at today's hearing. However, a letter dated 12.01.2026 diarized in the Commission vide diary no. 1285 dated 19.01.2026 mentioning therein that he is a senior citizen and the respondent PIO is intentionally harassing him by not providing the information, as two years have already been lapsed, despite that no reply/information has been provided to him.

3. Neither the PIO nor any of his representative is present, at today's hearing. They have also not sent any intimation regarding their non-availability.

4. From the perusal of the case file, it is ascertained that the respondent PIO has not addressed the RTI application within the stipulated time, as prescribed under the RTI Act, 2005, which shows his careless and casual attitude towards the Order of the Commission. There is nothing on record to show that the PIO O/o Panchayat Secretary, Gram Panchayat, Kachha Seed Farm, Abohar, District Fazilka has done anything to deal with this RTI application. Accordingly, the Commission deems it fit to issue this Show Cause Notice.

5. The **respondent PIO O/o Panchayat Secretary, Gram Panchayat, Kachha Seed Farm, Abohar, District Fazilka**, is herewith ordered to **SHOW CAUSE** as to why a penalty should not be imposed upon him under Section 20 (1) of RTI Act, 2005, for causing willful delay/denial of the information requested by the appellant as far back as on 14.02.2024. He/she should file a written reply in

response to the show cause notice as to why the appellant should not be compensated for the mental harassment suffered by him for not getting the information. **If there is / are other PIO / PIOs responsible for the delay in providing the information, the incumbent PIO is directed to inform such PIO(s) of the Show Cause and direct them to appear before the Commission along with written replies.**

“In addition to the written reply, the respondent PIO is also given an opportunity under Section 20 (1) provision there to, for a personal hearing before the imposition of such penalty on the next date of hearing. He may take note that in case he does not file his written reply and does not avail himself of the opportunity of personal hearing on the date fixed, it will be presumed that he has nothing to say and the Commission shall proceed to take further proceedings against him *ex parte*.”

6. The respondent PIO O/o Panchayat Secretary, Gram Panchayat, Kachha Seed Farm, Abohar, District Fazilka, is further directed to attend the next Hearing of this Appeal Case in person at the Commission in Chandigarh, along with a written, point wise reply to the RTI application and duly attested copies of all the information requested. Failure to attend the Hearing will compel the Commission to ensure his presence through service of a **Bailable Warrant**.

public activity or public interest. On the other hand, the disclosure of which would cause unwarranted invasion of privacy of that individual. The Commission observed that in the written submission of the respondent dated 20.11.2025, the information was denied by the PIO under section 8 (1) (J) & (h) of the RTI Act, 2005 since the matter is pending and has not reached its conclusive end. At this stage, disclosure of the information would impede the process of investigation.

5. Under these circumstances, **last opportunity** is awarded to the appellant to make a written submission to demonstrate what larger public interest would be served by disclosure of the said information and no further adjournment will be given in the instant appeal case.

5. Both the parties are also directed to remain present for deliberations to take the matter to its logical end. Failure to attend the Hearing will compel the Commission to ensure their presence through service of a **Bailable Warrant**.

6. With this, the case is **adjourned to 10<sup>th</sup> March, 2026 at 12.00 Noon for hearing at Chandigarh**.

**ORDER:**
