ORDER

The RTI application is dated 22.03.2023 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 12.06.2023 and second appeal was filed in the Commission on 11.11.2024 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act). Notice of hearing was issued to the parties for hearing for today i.e. 22.01.2026.

2. The appellant submits that the directions may be issued to the respondent PIO to supply the complete information. However, the respondent PIO is absent without intimation. It is a fact that a notice of hearing was sent to him through registered post but even though he is absent.

3. Viewing the attitude in dealing with the RTI application by the respondent casually, **Sh. Sukhdev Singh, Executive Officer-cum-Public Information Officer**, is, thus, issued a show cause notice to explain in a self-attested affidavit as to why a penalty @ Rs.250/- per day of delay subject to a maximum of Rs.25000/- till the complete information is furnished, be not imposed under Section 20(1) of RTI Act, 2005 on him for causing willful delay/denial of the information to the RTI applicant and to show cause why a compensation under section 19(8) of the RTI Act, 2005, may not be paid to the appellant for causing willful delay/denial of the information for detriment suffered by him.

3. It is also a fact that the appellant has filed other case bearing Appeal case no. 6911 of 2024, in which he has sought the similar information. The relevant portion of the sought information in Appeal Case No. 6911 of 2024 is as follows:

NOTE- The undersigned is a senior citizen and due to foot drop is adviced for bed rest by the doctor and hence should not be called for any type of investigation etc. The subjected RTI is being filed as per the rules and regulations of the RTI Act 2005 and if this RTI Application or its part does not pertians to the subjected PIO than it should be transfered to the appropariate PIO under Section 6(3) with intimation to the undersigned.

4. In light of the above and in the interest of natural justice, **one opportunity** is granted to the appellant to make the submissions whether his request to get the information is sustainable in the eyes of Law and why not he be debarred for 180 days for filing the RTI applications for such a lapse which appears to be willful and intentional. Although the appellant has a legal right to get the information being a Citizen of India but on the other side he has not right to misuse the process of Law by harassing the public authorities and is a burden on the State Exchequer. As such, he is directed to file the written submission failing which it will be presumed that he has nothing to say in this case and the Commission will proceed as per the procedure established by law.
